The College of the European Public Prosecutor's Office (EPPO),

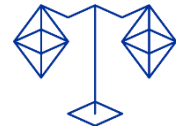
Having regard to the Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), hereinafter referred to as 'the EPPO Regulation'¹, and in particular Articles 9, 18 and 96 thereof,

Having regard to the Staff Regulations of Officials of the European Communities (hereinafter referred to as "the Staff Regulations"), and the Conditions of Employment of Other Servants of the European Communities (hereinafter referred to as "the CEOS"), laid down by Council Regulation (EEC, EURATOM, ECSC) n° 259/681, and in particular Articles 43, 44 and 46 of the Staff Regulations and Articles 14, 15 and 20 of the CEOS²,

Having regard to the Decision 047/2025 of the College of the EPPO of 4 June 2025 concerning the probationary period, the management trial period and the annual appraisal of the Administrative

Director of the European Public Prosecutor's Office ('EPPO'), hereinafter referred to as "the College Decision 047/2025", and in particular Article 10 thereof,

Whereas, according to Article 10 of the College Decision 047/2025, the Reporting Panel provided for in that decision shall be composed of three members of the College, one of which shall be chosen among the Deputy European Chief Prosecutors, and it shall be appointed by the College on a proposal of the European Chief Prosecutor.

Upon proposal of the European Chief Prosecutor,

Has adopted this Decision:

Article 1
