



# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 28 APRIL 2021

## ADOPTING OF CERTAIN IMPLEMENTING RULES TO THE STAFF REGULATIONS AND THE CONDITIONS OF EMPLOYMENT

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO') (hereinafter referred to as 'the EPPO Regulation')<sup>1</sup>, and in particular Article 96(4) thereof,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, and in particular Article 110(2) of the Staff Regulations,

Pending the establishment of EPPO Staff Committee and without prejudice of that consultative body position when established,

Whereas:

- (1) According to Article 96(1) of the EPPO Regulation, the Staff Regulations and the CEOS apply to the European Chief Prosecutor and the European Prosecutors, the European Delegated Prosecutors, the Administrative Director and the staff of the EPPO, unless otherwise provided for in this Regulation.
- (2) Article 96(4) of the EPPO Regulation states that the College of the EPPO adopts implementing rules to the Staff Regulations and to the CEOS.
- (3) On 3 February 2021, pursuant to Article 110(2) of the Staff Regulations and in compliance with Point 2.B of the Commission Guidelines on the implementation of Article 110(2) of the Staff Regulations<sup>2</sup>, the Commission notified the EPPO of its implementing rules to the Staff Regulations and the CEOS and its *ex ante* agreements given to the agencies/bodies.
- (4) As the EPPO is considered as being set up, the EPPO's general implementing provisions adopted provisionally by the interim Administrative Director on 4 February 2020 pursuant

to Article 20 of the EPPO Regulation should be replaced by rules adopted by the College in accordance with Article 96(6) of the EPPO Regulation and Article 110 of the Staff Regulations.

HAS DECIDED AS FOLLOWS:

### Article 1

The Commission Decisions implementing Staff Regulations and Conditions of Employments of Other Servants referred to in Annex, shall apply by analogy in the EPPO.

### Article 2

1. This Decision shall enter into force on the day following that of its adoption.
2. On the date of the entry into force of this Decision, the corresponding Implementing Rules adopted by the Decision of 4 February 2020 of the interim Administrative Director of EPPO shall cease to apply.
