## ON THE ADOPTION OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE ('EPPO') AMENDING BUDGET NO 3 FOR THE YEAR 2022

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 1939/2017 of 12 October 2017<sup>1</sup>, implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), hereinafter "the constituent act", and in particular Article 92 thereof,

Having regard to Decision 002/2021 of the College of the European Public Prosecutor's Office on the Financial Rules applicable to the EPPO, hereinafter referred to as "EPPO's Financial Rules", and in particular Article 34 thereof,

Whereas:

In accordance with Article 34 of the Decision 002/2021 of the College of the European Public Prosecutor's Office on EPPO's Financial Rules an amending budget of the EPPO shall be adopted by the same procedure as the initial budget of the EPPO in accordance with the provisions of the constituent act.

In accordance with Article 92 (7) of the constituent act, the College shall adopt the amending budget of the EPPO on a proposal from the European Chief Prosecutor.

Has adopted the following decision:

#### Article 1

The European Public Prosecutor's Office amending budget No 3 for 2022, as annexed to this Decision is hereby adopted.
