Having regard to Council Regulation (EU) 1939/2017 of 12 October 2017¹, implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), and in particular Article 92 thereof,

Having regard to Decision of the College of the European Public Prosecutor's Office of 13 January 2021 on the Financial Rules applicable to the EPPO², and in particular Article 72 thereof,

Whereas:

The budgetary implementation shall be preceded by a financing decision with the exception of administrative appropriations that may be implemented without a prior financing decision.
