

# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 14 APRIL 2023

## ON THE DISMISSAL OF ONE EUROPEAN DELEGATED PROSECUTOR OF THE EPPO IN THE REPUBLIC OF BULGARIA

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO') (hereinafter referred to as 'the EPPO Regulation')<sup>1</sup>, and in particular Article 17 thereof,

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants ('CEOS') of the European Union<sup>2</sup>,

Having regard to the Conditions of Employment of the European Delegated Prosecutors (hereinafter referred to as "COEEDP")<sup>3</sup>, and in particular Article 24 thereof,

Whereas:

- (1) The European Delegated Prosecutors shall, from the time of their appointment until dismissal, be active members of the public prosecution service or judiciary of the respective Member States which nominated them.
- (2) The College of the EPPO shall dismiss a European Delegated Prosecutor if it finds that he/she no longer fulfils the requirements set out in Article 17(2) of the EPPO Regulation.
- (3) The contract of Employment of a European Delegated Prosecutor shall be terminated by the EPPO without notice if the College, under a reasoned proposal made by the European Chief Prosecutor, finds that the European Delegated Prosecutor no longer fulfils the requirements set out in Article 17(2) of the EPPO Regulation or is unable to perform his/her duties for other reasons.

- (4) Mr. Ivaylo ILIEV, European Delegated Prosecutor in the Republic of Bulgaria, informed the EPPO on 7 April 2023 that he is has been appointed to the position of assistant of the National Member of Bulgaria at Eurojust as of 1 May 2023.
- (5) As a consequence, he will no longer fulfil the conditions to be employed by the EPPO set out in Article 17(2) of the EPPO Regulation.
- (6) Considering the proposal to dismiss Mr. Ivaylo ILIEV made by the European Chief Prosecutor dated 11 April 2023, and the documents accompanying the dismissal.

Has adopted the following decision:

### Article 1

The following person is hereby dismissed as European Delegated Prosecutor of the EPPO in the Republic of Bulgaria as of 1 May 2023:

- Mr. Ivaylo ILIEV.

### Article 2

The contract of employment as special adviser with the EPPO concluded with the person mentioned in Article 1 shall be terminated on 30 April 2023, in accordance with Article 24 of the CEEDP, and his term of office as European Delegated Prosecutor of the EPPO is deemed to be concluded on the same date.

### Article 3

This Decision shall enter into force on the day of its adoption.
