

## DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 15 JUNE 2023

## AMENDING COLLEGE DECISION 035/2023 OF 7 JUNE 2023, DESIGNATING A EUROPEAN DELEGATED PROSECUTOR PURSUANT TO ARTICLE 16(7) OF THE FPPO REGULATION

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 2017 /1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ("EPPO") (hereinafter referred to as "the EPPO Regulation"), and in particular Articles 13(2), 16(7), 17 and 96 thereof,

Having regard to Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Community of Atomic Energy, hereinafter referred to as "the Staff Regulations" and, respectively "the CEOS", and in particular to Articles 123 of the CEOS,

Having regard to Decision of the College of the European Public Prosecutor's Office of 29 September 2020 laying down rules on condition of employment of the European Delegated Prosecutor, as subsequently amended and supplemented (hereinafter referred to as "the CEEDP"), and in particular Article 14-16 thereof,

Having regard to the Decision of the College of the European Public Prosecutor's Office of 24 February 2021 laying down rules on the rights of the European Delegated Prosecutors designated to substitute the European Prosecutor of their Member State (hereinafter "the College Decision 013/2021"),

Having regard to College Decision 035/2023 of 7 June 2023, designating Mr Rui Correia Marques, European Delegated Prosecutor, to substitute the Portuguese European Prosecutor in case he is unable to carry out his functions or left his position pursuant to Article 16(7) of the EPPO Regulation, until 28 July 2023 and assigning additional tasks already allocated to the substitute EDP by College Decision of 19 May 2021, pursuant to Article 3(2) of the College Decision 013/2021,

Considering that Mr. Correia Marques has exercised such additional functions with no interruption since 1 June 2022, and that Decision 035/2022 was meant to prolong the assignment until 28 July 2023 ensuring the continuity of the functions



Considering that the date of entry into force of Decision 035/2023 should be maintained but that the entitlement to the allowance provided for in Article 3 (2) of College Decision 013/2021 should reflect the continuity of service,

Has adopted the following decision:

## Article 1

**Amendment** 

Article 3 of College Decision 035/2023 of 7 June 2023 shall be amended as follows:

"This decision shall enter into force on the date of its adoption. The rights under Article 3 (2) of College Decision 013/2021 shall be attributed to Mr. Rui Correia Marques as of 1 June 2023."

## Article 2

Entry into force

This decision shall enter into force on the date of its adoption.
