

DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 21 FEBRUARY 2024

APPROVING A REQUEST FOR ADDITIONAL STATUTORY POSTS AND ADDITIONAL REVENUE FOR 2024

The College of the European Public Prosecutor's Office (EPPO),

Having regard to Council Regulation (EU) 1939/2017 of 12 October 2017¹ implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), and in particular Article 92 thereof,

Whereas the EPPO needs additional financial and human resources in order to finalise EPPO's IT autonomy from the European Commission, to on-board the additional participating Member States and to continue building capacity during 2024,

Has adopted the following decision:

Article 1

The College approves the request for additional revenue and expenditure and additional posts to be submitted to the EU budgetary authority, as described in the Annex which forms an integral part of this Decision.

Article 2

This decision shall enter into force on the day following its adoption.
