

DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 16 DECEMBER 2024

ON THE APPOINTMENT OF EUROPEAN DELEGATED PROSECUTORS IN THE REPUBLIC OF POLAND

The College of the European Public Prosecutor's Office (EPPO),

Having regard to the Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO'), hereinafter referred to as "the EPPO Regulation", and in particular Articles 9, 13, 17 and 96 thereof,

Having regard to the Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Community of Atomic Energy, the latter hereinafter referred to as "the CEOS", and in particular to Articles 5, 123 to 124 of the CEOS,

Having regard to the Decision 001/2020 of the College of the EPPO of 29 September 2020 laying down rules on Conditions of employment of the European Delegated Prosecutors, as subsequently amended and supplemented, hereinafter referred to as "CEEDP", and in particular Articles 1 to 3 thereof,

Having regard to the Decision 013/2020 of 16 November 2020 of the College of the EPPO laying down rules on the procedure for the appointment of the European Delegated Prosecutors, and in particular Articles 2 and 4 thereof,

Having regard to the Commission Decision (EU) 2024/807 of 29 February 2024 confirming the participation of Poland in the enhanced cooperation on the establishment of the European Public Prosecutor's Office, hereinafter referred to as "the Commission Decision 2024/807",

Considering the proposal made by the European Chief Prosecutor on 11 December 2024, and the documents accompanying the nominations made by the Republic of Poland,

Has adopted this decision:

Article 1

The following persons are hereby appointed European Delegated Prosecutors in the Republic of Poland for a renewable period of five years:

- Ms. Katarzyna FURCZYK,
- Ms. Magdalena GUGA,
- Mr. Tomasz Michał JANDZIAK,
- Mr. Łukasz KLIMAS,
- Mr. Bolesław LASZCZAK,
- Ms. Agnieszka MARCIŃCZYK,
- Ms. Małgorzata TURLEWICZ,
- Mr. Przemysław WALAT.

Article 2

The persons mentioned in Article 1 shall conclude a contract of employment as special advisors with the EPPO, in accordance with Article 96(6) of the EPPO Regulation and Articles 1 to 2 of the CEEDP. The five year term in office shall start from the date mentioned in that contract.

Article 3

1. This decision shall enter into force on the date of its adoption.
2. In accordance with Article 2(2) of the Commission Decision 2024/807, the Polish European Delegated Prosecutors will exercise the tasks provided for in Articles 24 to 27 and 31 of the EPPO Regulation from the twentieth day of the appointment of the European Prosecutor from Poland in accordance with Article 16 of the same Regulation.
