

DECISION OF THE COLLEGE OF THE
EUROPEAN PUBLIC PROSECUTOR'S OFFICE
OF 26 FEBRUARY 2025

DESIGNATING A EUROPEAN DELEGATED PROSECUTOR
PURSUANT TO ARTICLE 16(7) OF THE EPPO REGULATION,
ASSIGNING ADDITIONAL TASKS, AND REPLACING THE
DECISION 022/2024 OF THE COLLEGE OF THE EPPO

The College of the European Public Prosecutor's Office (EPPO),

Having regard to the Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('the EPPO') (hereinafter referred to as "the EPPO Regulation"), and in particular Articles 13(2), 16(7), 17 and 96 thereof,

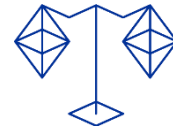
Having regard to the Regulation No 31 (EEC), 11 (EAEC), laying down the Staff Regulations of Officials and the Conditions of Employment of Other Servants of the European Economic Community and the European Community of Atomic Energy, hereinafter respectively referred to as "the Staff Regulations" and "the CEOS" and in particular to Article 123 of the CEOS,

Having regard to the Decision 001/2020 of the College of the European Public Prosecutor's Office of 29 September 2020 laying down rules on the conditions of employment of the European Delegated Prosecutors, as subsequently amended and supplemented (hereinafter referred to as "the CEEDP"), and in particular Articles 14 to 16 thereof,

Having regard to the Decision 003/2020 of the College of the European Public Prosecutor's Office of 12 October 2020 on the Internal Rules of Procedure of the EPPO (hereinafter referred to as "the Internal Rules of Procedure"), as subsequently amended and supplemented, and in particular Articles 31 and 34 thereof,

Having regard to the Decision 002/2021 of the College of the European Public Prosecutor's Office of 13 January 2021 on the Financial Rules applicable to the EPPO, as subsequently amended, (hereinafter "the Financial Rules"), and in particular Article 78 thereof,

Having regard to the Decision 013/2021 of the College of the European Public Prosecutor's Office of 24 February 2021 laying down rules on the tasks and rights of the European Delegated Prosecutors designated to substitute the European Prosecutor of their Member State (hereinafter "the College Decision 013/2021"),



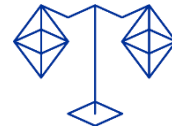
WHEREAS:

- (1) By Decision 022/2024 of the College of the EPPO of 20 March 2024 designating a European Delegated Prosecutor pursuant to article 16(7) of the EPPO Regulation ("College Decision 022/2024"), Ms Claudia Angermaier, European Delegated Prosecutor in the Republic of Austria, has been designated to substitute the European Prosecutor from the Republic Austria until 31 March 2025 and has been assigned with additional coordination tasks.
- (2) On 13 February 2025, Ms Ursula Schmudermayer, European Prosecutor from the Republic of Austria, submitted a reasoned proposal proposing to the College to approve:
 - the designation of Ms Christina Jilek, European Delegated Prosecutor in the Republic of Austria, to substitute the Austrian European Prosecutor in case she is unable to carry out her functions or left her position pursuant to Article 16(7) of the EPPO Regulation, with effect from 1 March 2025 and until 28 February 2026;
 - the assignment to Ms Christina Jilek of the additional tasks allocated to the European Delegated Prosecutor designated to substitute the European Prosecutor from Austria by the College Decision 022/2024, pursuant to Article 3(2) of the College Decision 013/2021, with effect from 1 March 2025 until 28 February 2026.

Moreover, in her proposal, Ms Ursula Schmudermayer, European Prosecutor from the Republic of Austria, presented justified reasons to designate Ms Christina Jilek to substitute her as of 1 March 2025, and therefore replacing in this capacity Ms Claudia Angermaier before the end of her designation pursuant to the College Decision 022/2024.

Acknowledging that, in line with Article 16(7) of the EPPO Regulation and according to the College Decision 013/2021, it is for the European Prosecutor of a Member State to make a reasoned proposal with regard to the European Delegated Prosecutor from that Member State who shall be designated to substitute the European Prosecutor and on assigning additional tasks. The European Prosecutor, for justified reasons, may modify or revoke that proposal and, consequently, the College may replace or revoke its decisions adopted in application of Article 16(7) of the EPPO Regulation and of the College Decision 013/2021.

Observing that, should the College approve the proposal made by Ms. Ursula Schmudermayer, European Prosecutor from the Republic of Austria, on 13 February 2025, the effects of the College



Decision 022/2024 shall cease as of 1 March 2025 and, from that date, the College Decision 022/2024 shall be replaced by a new decision.

Has adopted this Decision:

Article 1

Designation pursuant to Article 16(7) EPPO Regulation

The College approves the designation of Ms Christina Jilek, European Delegated Prosecutor in the Republic of Austria, to substitute the Austrian European Prosecutor in case she is unable to carry out her functions or leaves her position pursuant to Article 16(7) of the EPPO Regulation, for a period of one (1) year starting from 1 March 2025 until 28 February 2026.

Article 2

Additional Tasks

The College approves the assignment, for the period mentioned in Article 1, of additional coordinating tasks to Ms Christina Jilek, European Delegated Prosecutor in the Republic of Austria, pursuant to Articles 2 and 3(2) of the College Decision 013/2021.

Article 3

Replacement

The College Decision 022/2024 shall be replaced by this Decision and shall cease its effects as of 1 March 2025.

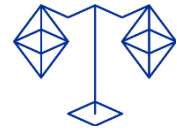
Article 4
