#### The EPPO

Under the leadership of the European Chief Prosecutor (`ECP`), the European Public Prosecutor's Office ('the EPPO') is the first European Union independent Prosecution Office of the European Union. The EPPO is responsible for carrying out criminal investigations and prosecutions into crimes affecting the Union budget in 24 EU Member States as one of the European Union Institutions and Bodies delivering the European Union's Justice System. It became operational on 1 June 2021.

The EPPO working language is English.

#### National Officials' secondment to the EPPO

To build on competences of national administrations and contribute to a smooth articulation between the central and decentralised components of its organisational model, the EPPO is seeking skilled individuals, employed in the above indicated Member State' judicial and investigative national, regional or local public administration, available to be seconded to the EPPO for fixed-term secondments under the status of Seconded National Experts ('SNE')<sup>2</sup>.

## An applicant should be an expert investigator of financial crimes, with ideally a focus on customs related offences.

Most competent candidates will be placed on a reserve list, which the EPPO draws from as specific needs for expertise and knowledge arise.

SNEs functionally report to the Chief European Prosecutor and are delegated to specific tasks during their period of secondment under the supervision of diverse functional areas' leaders.

#### **Duties and Accountabilities**

The selected candidate, under the authority of the European Chief Prosecutor in accordance with Article 98 of the EPPO Regulation, would be tasked with:

- giving legal and operational support to prosecutorial activities of the EPPO in the field of EU revenue, such as Traditional Own Resources offenses (ToR: customs duties, anti-dumping/countervailing, tobacco related offences,...), specifically providing legal advice and opinions to the Permanent Chambers in their directing and monitoring role, to the European Prosecutors in their supervising role, and to the European Delegated Prosecutors responsible for the investigations and prosecutions assigned to them;
- supporting the European Prosecutors and the European Delegated Prosecutors in their operational and investigative activity, liaising with the prosecutorial and judicial functions of the Member State in the process of consultation, exchange of information, possible coordination and other interactions in accordance with the EPPO Regulation and the legislation of the Member State;
- identifying and assessing possible issues at legal and operational level and drafting legal opinions, best practices, procedures, rules, decisions and other legal instruments in support of the activity of the Permanent Chambers, of the European Prosecutors and of the European Delegated Prosecutors;
- undertaking other tasks assigned by European Chief Prosecutor or by the supervising person delegated by him/her.

### Eligibility and selection requirements

### **Eligibility Criteria**

Applicants will be considered eligible for the selection based on the following formal criteria to be fulfilled by the deadline for applications:





- to be a national of the Federal Republic of Germany and enjoy the full rights as a citizen;
- to have a satisfactory knowledge of the working language of the EPPO and thorough knowledge of the German language to the extent necessary for the performance of the duties;
- to be employed by a public administration of the Federal Republic of Germany in accordance with Article 2(1) of the EPPO Regulation all public services of the Federal Republic of Germany of the European Union and central, federal and regional level, including government, prosecution, parliamentary and judicial services, law enforcement, customs authorities, the national courts, central banks, as well as the decentralised administrative services of the State and of such authorities;
- to have at least 3 (three) years` full-time experience of administrative, investigative, judicial, legal, scientific, technical, advisory or supervisory functions;
- must have worked for his/her employer on a permanent or contractual basis for at least 12 (twelve) months before the secondment and shall remain in service of the employer throughout the period of secondment;

# Applicants who meet the eligibility criteria will be assessed against the following selection criteria:

All essential criteria are mandatory, meaning that no application will be assessed further if a candidate does not fulfil at least one of the essential criteria.

You must provide specific examples of how you meet both the essential and advantageous requirements in the application form.

#### **Essential criteria**

- experience in investigating financial criminality cases in the Federal Republic of Germany, such as on EU revenue/customs related topics;
- experience in customs related topics and/or investigations: customs duties, antidumping, undervaluation, customs procedure, mineral oil, tobacco;
- knowledge of operational practices and regulations followed by investigators and law enforcement authorities in the Federal Republic of Germany;
- satisfactory knowledge of English, both written and spoken, as English is the working language of the EPPO. English will be used during the selection process.

#### **Advantageous criteria**

experience in investigating cross-border offences;





experience in customs related matters.

### **Interpersonal competencies**

- pro-active, highly flexible and dynamic working attitude, high sense of initiative, responsibility, discretion and confidentiality;
- critical and creative thinking and excellent analytical and problem solving skills, attention to details;
- strong inter-personal and negotiation skills;
- ability to prioritise and to organise activities/tasks/resources to deliver on several projects in parallel;
- ability to work independently as well as a part of a team, in a multi-cultural environment.
