# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 4 JUNE 2025

# DESIGNATING A EUROPEAN DELEGATED PROSECUTOR PURSUANT TO ARTICLE 16(7) OF THE EPPO REGULATION AND ASSIGNING ADDITIONAL TASKS

The College of the European Public Prosecutor's Office ('the EPPO'),

Having regard to Council Regulation (EU) 2017 /1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ("the EPPO") (hereinafter referred to as "the EPPO Regulation"),<sup>1</sup> and in particular Articles 13(2), 16(7), 17 and 96 thereof,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and to the Conditions of employment of other servants of the European Union ('CEOS'),<sup>2</sup> and in particular to Article 123 of the CEOS,

Having regard to the Decision 003/2020 of the College of the EPPO of 12 October 2020 on the Internal Rules of Procedure of the EPPO (hereinafter referred to as "the Internal Rules of Procedure"), as subsequently amended and supplemented,<sup>3</sup> and in particular Articles 31 and 34 thereof,

Having regard to the Decision 015/2025 of the College of the EPPO of 12 February 2025 on the Conditions of employment of the European Delegated Prosecutors, and replacing and repealing Decisions 001/2020, 013/2020, 017/2021, 013/2021, 098/2021, 007.2023 and 058/2024 of the College of the EPPO (hereinafter referred to as the "CEEDP"), and in particular Articles 20 and 21 thereof,

Having regard to the Decision 002/2021 of the College of the EPPO of 13 January 2021 on the Financial Rules applicable to the EPPO, as subsequently amended (hereinafter referred to as "the Financial Rules"),<sup>4</sup> and in particular Article 78 thereof,

#### Whereas:

- (1) On 16 February 2025, Ms Grazyna STRONIKOWSKA, European Prosecutor, made a reasoned proposal to the College:
- to approve the designation of Ms Agnieszka MARCIŃCZYK, European Delegated Prosecutor in the Republic of Poland, to substitute her in case she is unable to carry out her functions or leaves her position pursuant to Article 16(7) of the EPPO Regulation, and
- to approve the assignment of additional tasks for a duration of one year to Ms Agnieszka MARCIŃCZYK, European Delegated Prosecutor, as proposed in the above-mentioned reasoned proposal, namely:
  - a) to represent the European Prosecutor from Poland and the EPPO in Poland for institutional and administrative matters to be discussed with the competent national authorities, when these activities are not performed by European Prosecutor;
  - b) to coordinate the activities of the administrative staff who put at the disposal of the EPPO in Poland;
  - c) to coordinate in close connection with the central level of EPPO and with the supervising European Prosecutor the relations with the media and communication.
  - d) to conduct other coordination tasks on the national level assigned to her by the European Prosecutor from Poland.
- (2) By the Decision 020/2025 of the College of the EPPO of 26 February 2025 designating a European Delegated Prosecutor pursuant to Article 16(7) of the EPPO Regulation, the College approved that reasoned proposal.
- (3) The College acknowledges the need to specify concretely the additional tasks assigned to Ms Agnieszka MARCIŃCZYK and the request of the European Prosecutor from Poland to assign these tasks for an indefinite period.

#### Article 1

#### Designation pursuant to Article 16(7) EPPO Regulation

The College confirms the designation of Ms Agnieszka MARCIŃCZYK, European Delegated Prosecutor in the Republic of Poland, to substitute the Polish European Prosecutor in case she is unable to carry out her functions or leaves her position pursuant to Article 16(7) of the EPPO Regulation, as approved by the College Decision 020/2025 of 26 February 2025.

#### Article 2

#### Additional Tasks

The College approves the assignment of additional tasks to Ms Agnieszka MARCIŃCZYK, European Delegated Prosecutor in the Republic of Poland, as proposed in the above-mentioned reasoned proposal, namely:

- a) to represent the European Prosecutor from Poland and the EPPO in Poland for institutional and administrative matters to be discussed with the competent national authorities, when these activities are not performed by European Prosecutor;
- b) to coordinate the activities of the administrative staff who put at the disposal of the EPPO in Poland;
- c) to coordinate in close connection with the central level of EPPO and with the supervising European Prosecutor the relations with the media and communication.
- d) to conduct other coordination tasks on the national level assigned to her by the European Prosecutor from Poland.

# Article 3

#### Replacement and repeal

On the date of the entry into force of this decision, the Decision 020/2025 of the College of the EPPO of 26 February 2025 is hereby replaced and repealed.

#### Article 4

#### Entry into force

This decision shall enter into force on the date of its adoption.
