

DECISION OF THE COLLEGE OF THE  
EUROPEAN PUBLIC PROSECUTOR'S OFFICE  
OF 2 JULY 2025

ON THE PROLONGATION OF THE DESIGNATION OF A  
EUROPEAN DELEGATED PROSECUTOR PURSUANT TO  
ARTICLE 16(7) OF THE EPPO REGULATION AND ASSIGNING  
ADDITIONAL TASKS

The College of the European Public Prosecutor's Office ('the EPPO'),

Having regard to Council Regulation (EU) 2017 /1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ("the EPPO") (hereinafter referred to as "the EPPO Regulation"),<sup>1</sup> and in particular Articles 13(2), 16(7), 17 and 96 thereof,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and to the Conditions of employment of other servants of the European Union ('CEOS'),<sup>2</sup> and in particular to Article 123 of the CEOS,

Having regard to the Decision 003/2020 of the College of the EPPO of 12 October 2020 on the Internal Rules of Procedure of the EPPO (hereinafter referred to as "the Internal Rules of Procedure"), as subsequently amended and supplemented,<sup>3</sup> and in particular Articles 31 and 34 thereof,

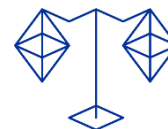
Having regard to the Decision 015/2025 of the College of the EPPO of 12 February 2025 on the Conditions of employment of the European Delegated Prosecutors, and replacing and repealing Decisions 001/2020, 013/2020, 017/2021, 013/2021, 098/2021, 007.2023 and 058/2024 of the College of the EPPO (hereinafter referred to as the "CEEDP"), and in particular Articles 20 and 21 thereof,

Having regard to the Decision 002/2021 of the College of the EPPO of 13 January 2021 on the Financial Rules applicable to the EPPO, as subsequently amended (hereinafter referred to as “the Financial Rules”),<sup>4</sup> and in particular Article 78 thereof,

Whereas:

- (1) By the Decision 027/2023 of the College of the EPPO of 26 April 2023 designating a European Delegated Prosecutor pursuant to Article 16(7) of the EPPO Regulation, the College designated Ms Mona POPESCU BOULIN to substitute the French European Prosecutor, for a period of two years, starting on 1 June 2023.
- (2) By a reasoned proposal dated 22 June 2025, Mr Frédéric BAAB, European Prosecutor, proposed to the College:

i) to approve the extension until 1 September 2026 of the mandate of Ms Mona POPESCU BOULIN, European Delegated Prosecutor, to substitute the French European Prosecutor in case he is unable to carry out his functions or left his position pursuant to Article 16(7) of the EPPO Regulation, and

ii) to approve the assignment of the above-mentioned additional tasks to Ms Mona POPESCU BOULIN, European Delegated Prosecutor, namely to:

- act as a contact point of EPPO in France for administrative matters and interinstitutional relations with the specialized jurisdictions and the courts, the bar associations and the partner administrations;
- ensure the coordination of the clerks and the legal assistants put at the disposal of the EPPO in France;
- deal with requests for information received from EPPO's Central Office.

Has adopted this decision:

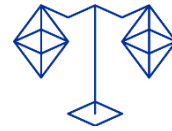
## Article 1

### *Designation pursuant to Article 16(7) EPPO Regulation*

The College hereby prolongs from 1 July 2025 until 1 September 2026 the designation of Ms Mona POPESCU BOULIN, European Delegated Prosecutor in the French Republic, to substitute the French

European Prosecutor in case he is unable to carry out his functions or leaves his position pursuant to Article 16(7) of the EPPO Regulation.

## Article 2

### *Additional Tasks*

The College approves the assignment of additional tasks to Ms Mona POPESCU BOULIN, European Delegated Prosecutor in the French Republic, as proposed in the above-mentioned reasoned proposal, namely to:

- act as a contact point of EPPO in France for administrative matters and interinstitutional relations with the specialised jurisdictions and the courts, the bar associations and the partner administrations;
- to ensure the coordination of the clerks and the legal assistants put at the disposal of the EPPO in France;
- to deal with requests for information received from EPPO's Central Office.

## Article 3

### *Entry into force*

This decision shall enter into force on the date of its adoption.
