EUROPEAN PUBLIC PROSECUTOR'S OFFICE  
OF 24 JULY 2025

ON THE DESIGNATION OF A EUROPEAN DELEGATED  
PROSECUTOR PURSUANT TO ARTICLE 16(7) OF THE EPPO  
REGULATION AND ASSIGNING ADDITIONAL TASKS

The College of the European Public Prosecutor's Office ('the EPPO'),

Having regard to Council Regulation (EU) 2017 /1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ("the EPPO") (hereinafter referred to as "the EPPO Regulation"),<sup>1</sup> and in particular Articles 13(2), 16(7), 17 and 96 thereof,

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and to the Conditions of employment of other servants of the European Union ('CEOS'),<sup>2</sup> and in particular to Article 123 of the CEOS,

Having regard to the Decision 003/2020 of the College of the EPPO of 12 October 2020 on the Internal Rules of Procedure of the EPPO (hereinafter referred to as "the Internal Rules of Procedure"), as subsequently amended and supplemented,<sup>3</sup> and in particular Articles 31 and 34 thereof,

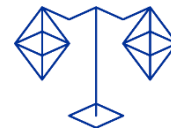
Having regard to the Decision 015/2025 of the College of the EPPO of 12 February 2025 on the Conditions of employment of the European Delegated Prosecutors, and replacing and repealing Decisions 001/2020, 013/2020, 017/2021, 013/2021, 098/2021, 007.2023 and 058/2024 of the College of the EPPO (hereinafter referred to as the "CEEDP"), and in particular Articles 20 and 21 thereof,

Having regard to the Decision 002/2021 of the College of the EPPO of 13 January 2021 on the Financial Rules applicable to the EPPO, as subsequently amended (hereinafter referred to as “the Financial Rules”),<sup>4</sup> and in particular Article 78 thereof,

Whereas:

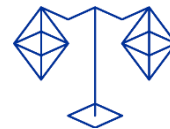
By a reasoned proposal dated 17 July 2025, Mr José LOPES RANITO, European Prosecutor, proposed to the College to:

- approve the designation of Ms Carla Susana FIGUEIREDO, European Delegated Prosecutor in the Republic of Portugal, to substitute the Portuguese European Prosecutor in case he is unable to carry out his functions or leave his position pursuant to Article 16(7) of the EPPO Regulation, with effect from 29 July 2025 and until 29 July 2026.
- approve the assignment to Ms Carla Susana FIGUEIREDO of the additional tasks already allocated to the substitute European Delegated Prosecutor by previously mentioned College Decision 031/2024, with effect from 29 July 2025 until 29 July 2026, namely to:
  - o to represent the European Prosecutor from Portugal and the EPPO for institutional and administrative matters to be discussed with the competent Portuguese authorities, when these activities cannot be performed by European Prosecutor;
  - o to coordinate the activities of the administrative staff who put at the disposal of the EPPO in Portugal;
  - o to coordinate – in close connection with the central level of EPPO and with the supervising European Prosecutor – the relations with the media and communication.
  - o to conduct other coordination tasks on the national level assigned by the European Prosecutor from Portugal.

## Article 1

### *Designation pursuant to Article 16(7) EPPO Regulation*

The College hereby approves the designation, from 29 July 2025 to 28 July 2026, of Ms Carla Susana FIGUEIREDO, European Delegated Prosecutor in the Republic of Portugal, to substitute the Portuguese European Prosecutor in case he is unable to carry out his functions or leaves his position pursuant to Article 16(7) of the EPPO Regulation.

## Article 2

### *Additional Tasks*

The College approves the assignment, for the period mentioned in Article 1, of additional tasks to Ms Carla Susana FIGUEIREDO, European Delegated Prosecutor in the Republic of Portugal, as proposed in the above-mentioned reasoned proposal, namely to:

- to represent the European Prosecutor from Portugal and the EPPO for institutional and administrative matters to be discussed with the competent Portuguese authorities, when these activities cannot be performed by European Prosecutor;
- to coordinate the activities of the administrative staff who put at the disposal of the EPPO in Portugal;
- to coordinate – in close connection with the central level of EPPO and with the supervising European Prosecutor – the relations with the media and communication.
- to conduct other coordination tasks on the national level assigned by the European Prosecutor from Portugal.

## Article 3

### *Entry into force*

This decision shall enter into force on the date of its adoption.
