

# DECISION OF THE COLLEGE OF THE EUROPEAN PUBLIC PROSECUTOR'S OFFICE OF 9 SEPTEMBER 2025

## ON THE COMPOSITION OF THE DISCIPLINARY BOARD FOR CASES CONCERNING MEMBERS OF THE COLLEGE OF THE EPPO

The College of the European Public Prosecutor's Office (EPPO),

Having regard to the Staff Regulations of Officials of the European Union ('Staff Regulations') and the Conditions of Employment of Other Servants of the European Union ('CEOS'), laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68<sup>1</sup>, and in particular the second paragraph of Article 22 and Article 86 of the Staff Regulations and Article 30 of Annex IX to the Staff Regulations,

Having regard to Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office ('EPPO') (hereinafter referred to as 'the EPPO Regulation'),

Considering that the Commission Decision C(2019) 4231 final of 12 June 2019 laying down general implementing provisions on the conduct of administrative inquiries and disciplinary proceedings (hereinafter "Commission's general implementing provisions") shall apply by analogy at the EPPO for cases where the person concerned is a member of the College until the College would adopt different implementing rules applicable to the members of the College,

Whereas it is necessary to establish a Disciplinary Board for cases where the person concerned is a member of the College of the EPPO.

HAS DECIDED AS FOLLOWS:

## Article 1

### *Composition of the Disciplinary Board*

- (1) Ms Rosario SILVA DE LAPUERTA is hereby appointed as chairperson of the Disciplinary Board for cases concerning members of the College ("the Disciplinary Board").
- (2) Mr João SANT'ANNA is hereby appointed as Chairperson alternate of the Disciplinary Board.
- (3) The following persons are hereby appointed as permanent members, and, respectively, alternate members of the Disciplinary Board:
  - Mr Lars BAY LARSEN, permanent member,
  - Mr Valter MAVRIC, permanent member,
  - Ms Ornella PORCHIA, permanent member,
  - Mr Peter XUEREB, permanent member,
  - Mr Kristian KNUDSEN, alternate member,
  - Ms Christine ROGER, alternate member.
- (4) The two additional members of the Disciplinary Board, as enlarged in accordance with Article 31 paragraph 1(b) of the Commission's general implementing provisions, in cases where a European Prosecutor (AD 13) is the person concerned, shall be two European Prosecutors with the highest seniority in age and who are not involved in any way in the matter which will be assessed by the Disciplinary Board.

## Article 2

### *Term*

Without prejudice to their career development, the chairpersons, the members and alternates shall be appointed for a period of three years, but not longer than the period of applicability to the members of the College of EPPO of the Commission's general implementing provisions.

## Article 3

### *Secretary to the Disciplinary Board*

The secretary of the Disciplinary Board and his/her alternate shall be appointed ad hoc, depending on the topic and their availability, from amongst staff members in function group AD.

## Article 5

### *Entry into force*

This Decision shall enter into force on the day following that of its adoption.
